
Edge matching (1)

- Question:
In 2017 and 2018 BKG provided hints for Data Producers where the edge matching should be checked for the hydrography and transport theme.
Did you have enough information and understand what the Production Management Team expected from you?
- Result:
 - Procedure was OK, nothing to improve for PMT



Edge matching (2)

- Question:
Did you contact your neighbour to start the edge matching process for the locations which were detected by BKG?
- Results:
 - Most Data Producers conducted edge matching process, edge matching should improve
 - Obstacles:
 - Being an island, no edge matching needed ☺
 - Not enough time
 - Political issues / no bilateral agreement




Edge matching (3)

 - Hints for TRANS will be provided by BKG




Theme: Named location (1)

- Question:

 - National database doesn't include this data
 - No idea how to derive national data into GNameT




Theme: Named location (2)

- Question:
Would it be possible for you to update the line feature class GNameL instead of the annotation feature class GNameT?




- Question:
The NAME theme holds only text features for named places that cannot be put into attributes. There is no elevation theme in ERM but peaks can be named in the NAME theme.
Are you able to provide the name and the height of peaks?

Are you able to stick to strict rules for populating the symbol identification SID for features in the NAME theme (like table 55 in ERM Technical Producer Guide)?
- Results:
 - Discussion how to go on with GNameT/GnameL during next Production Management Team Meeting





TEN network (1)


- Question:

Answers with "yes" and selected options





Are you able to update the attribute TEN?




- Results:

Are you able to update the attribute TENTEC-ID?




ERM Validator (1)

- Question:
Do you miss a check in the ERM Validator?
- Results:
 - For most Data Producers all checks are listed
 - Missing checks:
 - A "filter tool" that excludes the exceptions so that we can focus attention on the true positive issues
 - For some statistics, a percentage of the deviation from the standard would be more useful than a brute number: when compared to global statistics, some brute numbers can be relativised (for example: to short segments, to small areas, and so on).



ERM Validator (2)

- Question:
To improve the quality of the ERM Validator tool, we would like to set up a small group of Data Producers to test newly developed checks before they are incorporated in a new official version of the ERM Validator tool.
Would you like to participate in such a group of beta testers?
- Results:
 - Beta testers were selected.
They will test the tool before it will be released.





C# Tools

- Question:
For a long time C# Tools were used by Data Producers and the Production Management Team during production and validation of ERM data. Now the ERM Validator took over the validation checks.
Do you still use the C# Tools?
 - Translate (translates an input text field with diacritics into a correct US-ASCII text (e.g. NAMN1 into NAMA1 or NAMN2 into NAMA2)
 - EdgeMatchingLine (checks the edge matching of lines e.g. RoadL between two countries)
 - EdgeMatchingPolygon (checks the edge matching of polygons e.g. LandIceA between two countries)
- Results:
 - No Data Producer uses C# Tools any more


Availability of tools
