IMPULS project – basic facts

Financing:

- Sida, Swedish International Development Cooperation Agency



Implementation:

- Lantmäteriet, Swedish mapping, cadastral and land registration authority (leading partner)
- State Geodetic Administration, Croatia (junior partner)



Duration: 2014 – 2019

Total amount: 38 900 000 SEK (app. 4 million EUR)

Beneficiaries:

- 8 institutions in charge of providing basic spatial data and SDI from 6 countries in the Western Balkan Region (generally responsible as coordinators as well as primary data producers/providers).

Toward increasing practical knowledge (hands on work), capacity and supporting actual implementation of the **INSPIRE Directive**

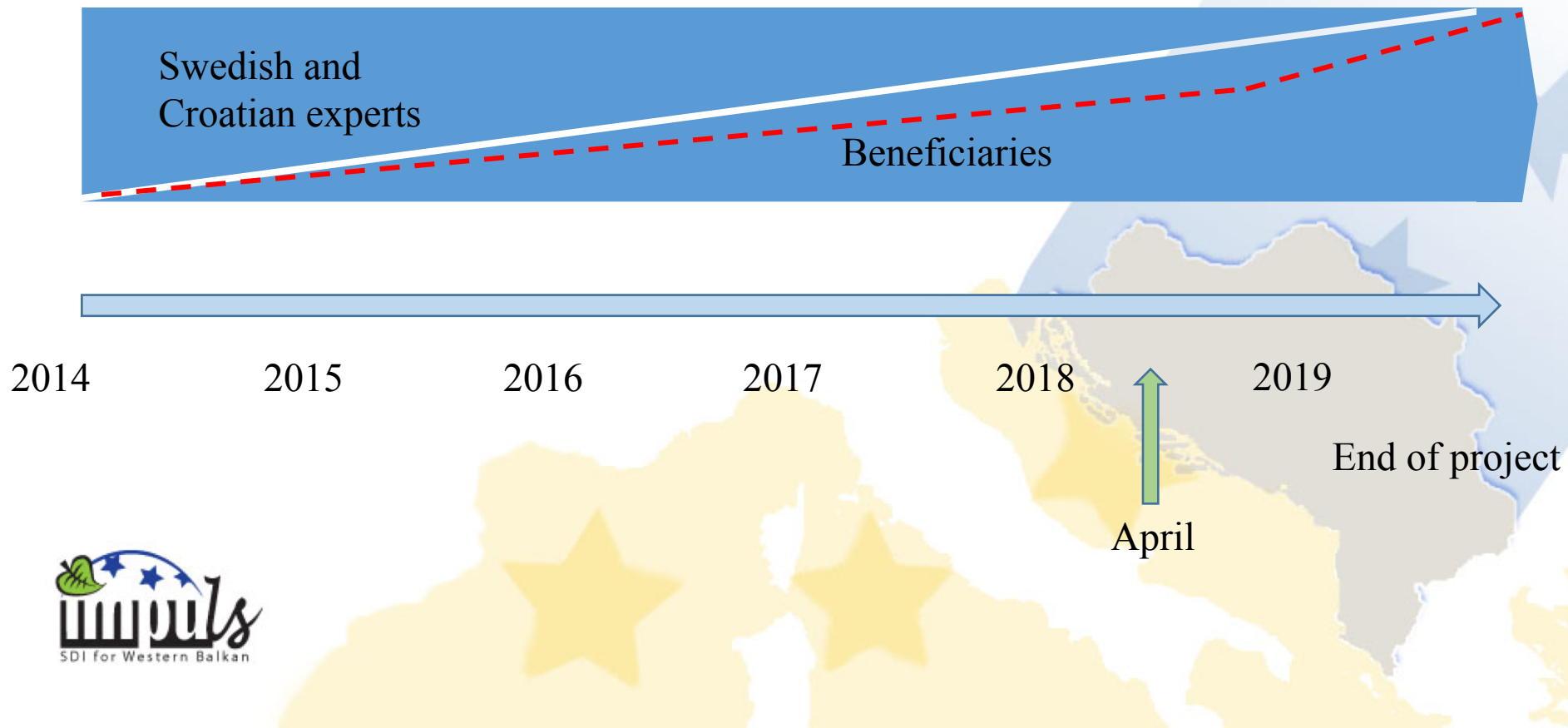
IMPULS is about cooperation

- IMPULS will provide the basis for:
 - How the exchange and use of information can be achieved;
 - How authorities should disseminate spatial data in an electronic format via services and;
 - How they should share geodata with other public authorities and also other countries.
- The Nordic countries cooperation - an input model for this project.
- The cooperation is within and between independent organisations.
- The cooperation are based on common frameworks and regulated in contracts and agreements.
- Without cooperation you have no SDI.

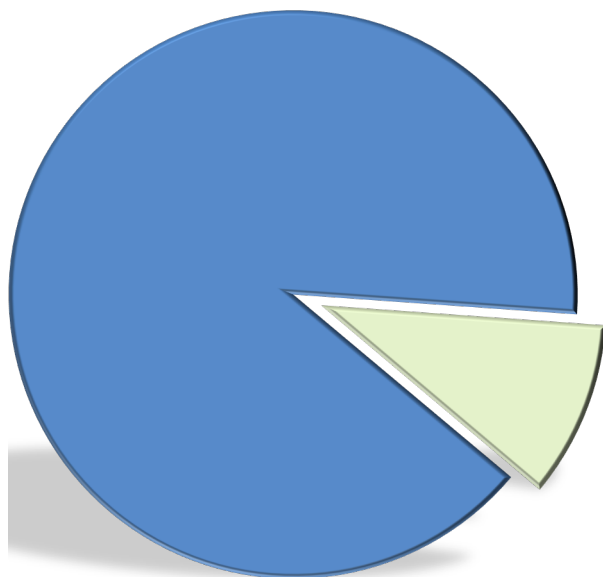


Time-schedule

Approach and methodology



■ 90 % work done at the respective BO

■ 10% workshops and other joint activities

Seminar – information activities, presentations, discussions => increasing knowledge by setting knowledge exchange network among BO's, presenting best practices, preparing for tasks to be implemented, setting a base for next step

Workshop – learning by doing, hands on work => giving tangible results, e.g. specification, technical framework, draft law, first meta data profile, doing action plans, data sharing models, etc.

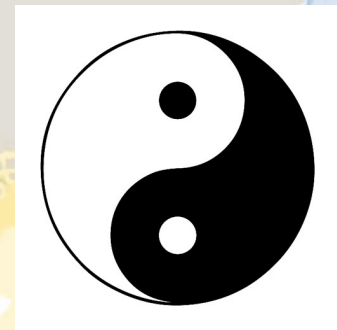
IMPULS - Outcome Statements

- Actively developing and promoting NSDI's









Priority tasks

2. **Services** are available for all the datasets
3. **Harmonised** data according to common specifications

Road trips 2016 and 2017

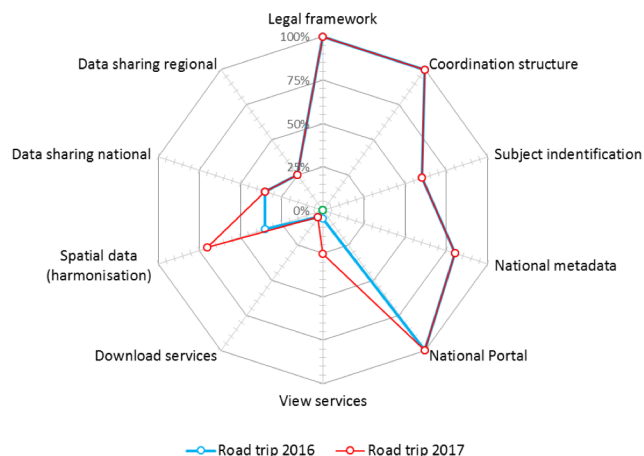
Swedish and Croatian experts looked together with the BO's on how each BO had performed within:

10. Data sharing regional

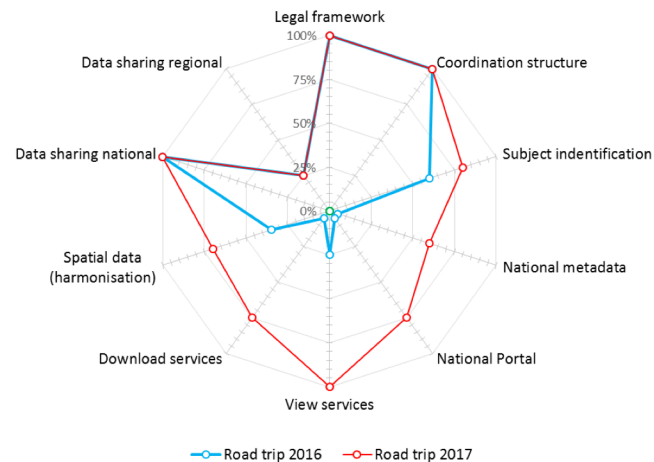

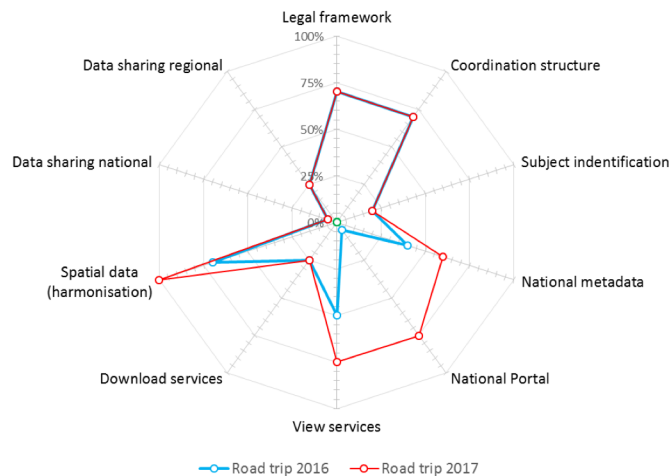
NSDI status - AREC



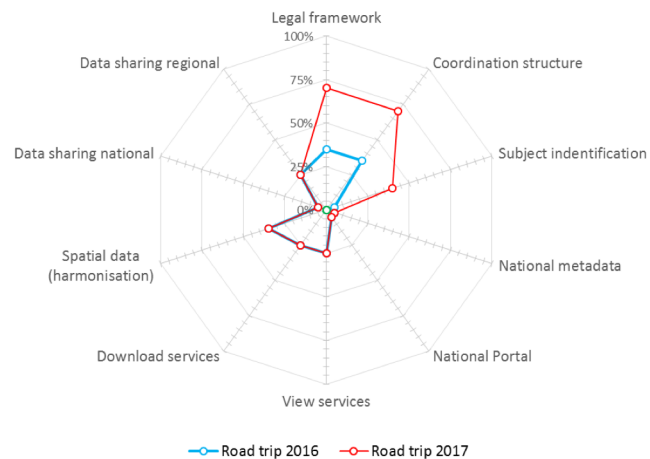
NSDI status - ASIG



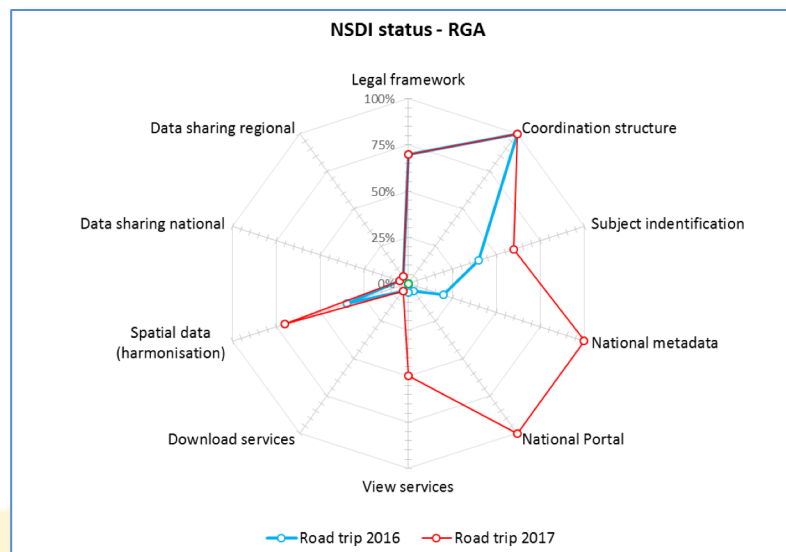
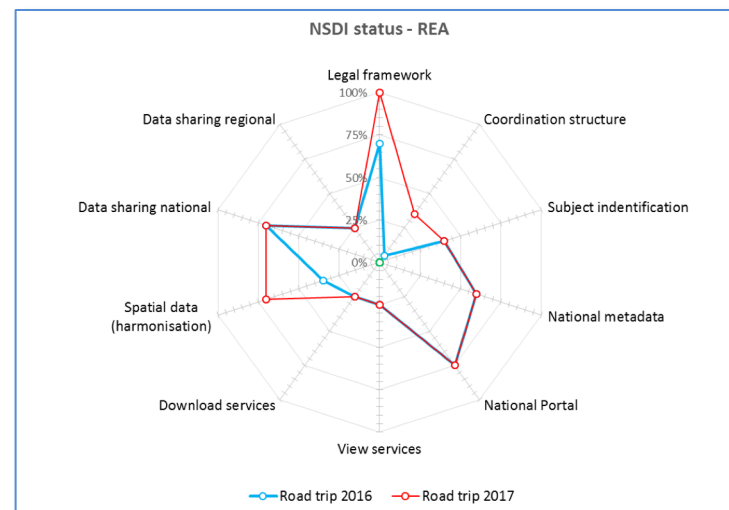
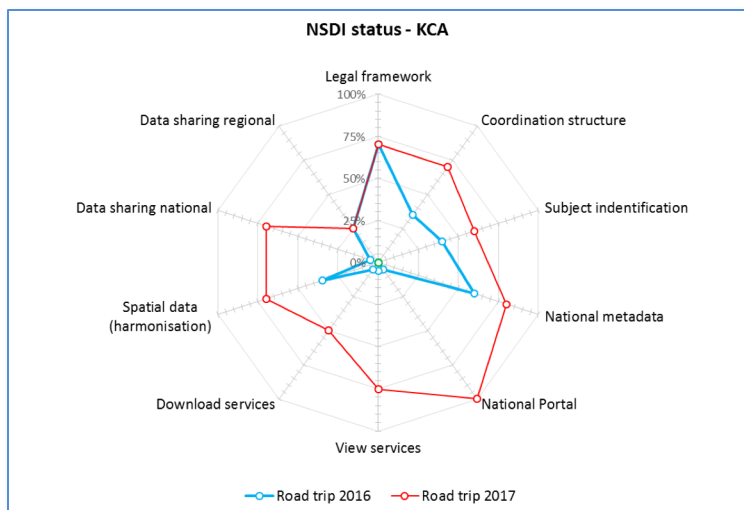
NSDI status - FGA

Expected project impact - Long term result

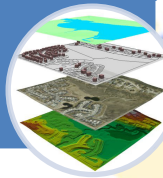
- INSPIRE Directive is implemented in the region, enabling the beneficiary countries to meet the EU-requirements in this area

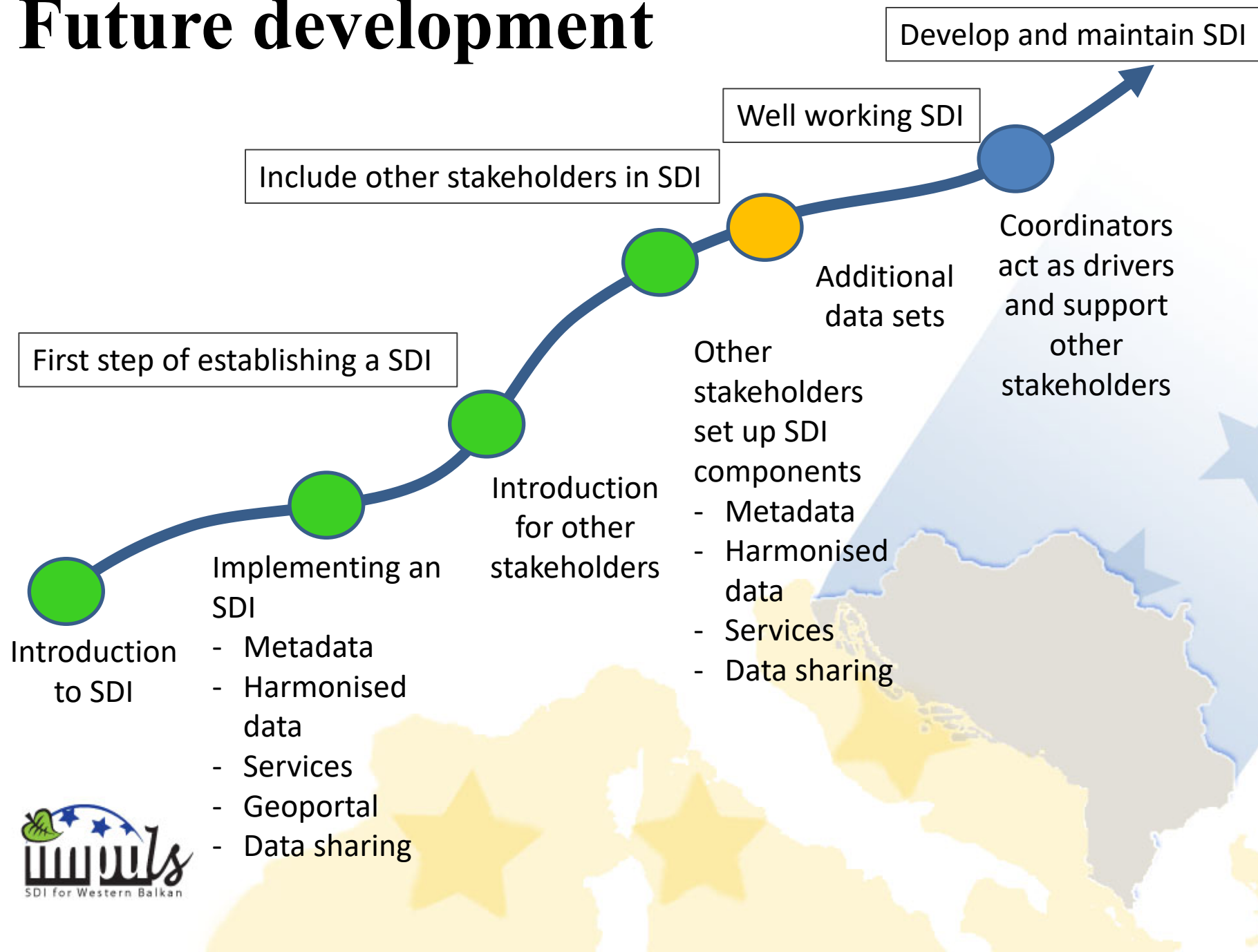
