






## **Formal Business**

# Remote voting procedure

- Heads (and Permanent Correspondents) from eligible members received an email explaining the voting procedure and a PDF voting form attached.
- The vote formally commenced at 17.00 CET October 6<sup>th</sup> 2020.
- Members were asked to have completed and returned their vote by email to Anne-Claire Bourdessol by 17.00 CET on 13<sup>th</sup> October 2020.
- 41 out of 53 eligible organisations responded by the deadline
- No response counted as Yes (as per the Articles of Association)
- All voting forms received via email by the deadline had their votes counted:
  - by the Finance Manager,
  - then the Head of Operations,
  - independently verified by Ingrid Vanden Berghe, Director General, NGI Belgium. (Thank you Ingrid!)
