- **General support of the 'Strategic Goals' of EuroGeographics**
 - Representation of the members at European and international level
 - Strong membership - network of members
 - Exchange of knowledge
 - Access to geospatial data of members
 - Implementation of a European Spatial Data Infrastructure (implementing INSPIRE)

Information on the PSI and Open Data directive

■ Background

- DIRECTIVE (EU) 2019/1024 OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL of 20 June 2019 on open data and the re-use of public sector information (recast)
- ‘EuroGeographics Information Paper’: Commission Proposal for recasting the Directive on Re-use of Public Sector Information in 2018

■ Decision of the European Commission

- Deloitte, consultant appointed by the Commission, to perform study into High Value Data sets for the Open Data PSI Directive, to inform future Implementing Acts

■ Benefits from EuroGeographics’ membership

- PolKEN meetings and webinars very helpful!
 - Information/Position Paper and Round Table national reports
- Evaluation and assessment of national positions in order to develop a EG position

➔ **EuroGeographics strengthens the effectiveness of and coordinates member’s representation of interests and positions, in particular with the European Union**

Legal support of the Database Directive case in the European Court of Justice

■ Background

- A private map publisher extracted information from official topographic maps of Bavaria (Germany) to produce leisure maps, without paying the required license fee

■ Decision of the European Court of Justice (ECJ)

- Amongst others, topographic maps, both analogue and digital, are to be considered as „database“ in the sense of Directive 96/9/EC
- Compliance of data base protection and licensing practice with EU legislation on authoritative geospatial information and its re-use

■ Benefits from EuroGeographics' membership

- 7 EG members provided supporting statements submitted to ECJ (AT, BE, DE, ES, IT, PL, PT)
- 6 EG members offered support for possible oral proceedings (EL, FR, HU, NL, UK: GB, GB-North Ireland)

➔ **EuroGeographics proofed efficiency and strength providing a European view on specific legal issues related to geospatial information management**
