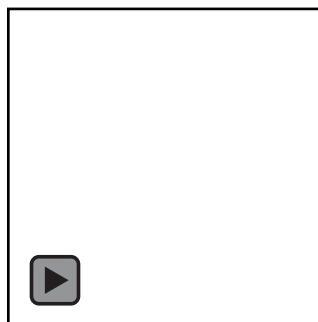

ERM validator tool

- Used by all countries
-> Normally it runs within one hour.
(Except for CH, it takes four hours on VDI (VirtualPC)).
- In general: Runs well and the group is very happy with the tool! 😊
- Problems / issues:
-> Need some changes with International Boundary and CFP (vertices).

Communications

- Production Management System (PMS)
 - > All countries have access
 - > Contacts are up-to-date
- BKG-ftp server
 - > All countries have access and have no problems
 - > Used for data exchange
- Additional knowledge exchange needed in a webinar?
 - > Not at this moment

- Please don't deliver the features on border! Only when there are changes 😊
- We are waiting for two more countries, and then we can send it to BKG.
- No data from Luxembourg this year, old version is being used.

Questions to BKG and Angela

- Question, on EBM status of validation
-> See the status of your EBM dataset on PMS.
- The new way of metadata is much better than the old excel documents! 😊
- Would it be possible to add a vertex to the International Boundary where a CFP is placed? Currently the tool gives an error if this is not the case.
-> It is not desired to add extra vertices to the International Boundary.
Maybe the ERM validator check can be adjusted.
