- Cadastral Index Map (CIM)
- GeoLocator and Regional Gazetteer (Geographical Names)

# What we need from you

  - WFS of Addresses, Buildings, Roads, Railroads; Cadastral Index Map (CP, AD, AU), GeoLocator (GN, AD, AU)
2. Have you INSPIRE compliant web-services of the products?
3. Can you provide the data / service to Open ELS priority product(s) under Open license agreement?
4. What constrains your contribution to Open ELS / ELS?
