

HYDRO

- Real updates
- Additional information if available (FC, attributes)
- Corrections from quality assessment ERMv8.0

→ No new requirements from Eurostat contract for producers in 2015



HYDRO tables

- LAKERES_WBSC:
 - PMT will create table automatically by ERM tool
- WATRCRS_MDC:
 - Check table provided by PMT from ERMv8
 - Add / delete HydroIDs if necessary
 - Special focus on cross-border rivers



HYDRO

- Only new information in ERMv9 will be WISE_ID
 - Identifier used in the „Water Information System for Europe“
- Will be added centrally at the end of the production process by PMT



HYDRO (and all other themes in future)

- Please deliver **all** Feature Classes and tables that belong to the requested theme!
- Include Feature Classes that are
 - not updated
 - empty
- Otherwise it is very difficult for RC to sort out which FCs have been updated and which FCs have to be copied from the previous ERM version.



Updates for other themes?

- Other themes (not BND or HYDRO)
 - will not be validated by RC
 - will not be included in delivery to customers

→Concentrate on BND and HYDRO



Delivery timetable for producers

- provide the **national production plan** for 2015: End of April 2015
- BND: delivery for EBM: End of June 2015 (no separate delivery to ERM)
- HYDRO: End of August 2015
- Metadata: Mid October 2015



Timetable for PMT

- Provide the **production plan** for 2015 to producers: 15th April 2015
- Final validation RC: Mid October 2015
- Aggregation, last validation, finalisation by PMT: November and December 2015



Special case: New countries

- Should deliver all themes according to accreditation plan (priority on themes that should be updated)
- All themes will be validated
- All themes will be included in delivery to Eurostat and other users
- Discuss delivery timetable with RC and PMT



Outlook production 2016 ERMv10

- Themes: BND, TRANS, POP
- For TRANS:
some new requirements from Eurostat contract
→PMT will investigate in 2015 what can be supplied by the producers (questionnaire)
