



## **Normative Framework**

- 2018: Law on State Survey and Real Estate Cadastre (Official Gazette 112/18)
- 2010: Act on Amendments to the State Survey and Real Estate Cadastre Act (Official Gazette 124/10)
  - "The following tasks are performed in the Central Office:
    - 10. establishing and keeping records of geographical names, "
- 1999: Law on State Survey and Real Estate Cadastre (Official Gazette 128/1999)
  - "The Institute performs the following tasks within its activities….
  - 4. organizes and keeps records of geographical names "

## The Register of Geographical Names


"The Register of Geographical Names is a record in which data on geographical names in the territory of the Republic of Croatia are kept and maintained, for which this is determined by this Act or special regulations."

- Appointed by Government in 2019
- President Director General of SGA, Ph.D. Damir Šantek
- Multidisciplinary and multi-institutional body experts in the field of geodesy, geography, linguistics, cartography, hydrography, history, culture, international relations and science and education
- Objective unique standardization of geographical names in the Republic of Croatia

On January 17, 2022, organized by the State Geodetic Administration, the seventh session of the Commission for Standardization of Geographical Names was held in a virtual environment

Geographical Names (Commission), Ph.D. Damír Šantek informed the members of the Commission and others present about the draft strategic documents in ensuring the quality of the Register of Geographical Names (RGI), which are the basis for solving certain problems of standardization of geographical names in the Republic of Croatia.

The leaders of the working groups presented to the Commission drafted documents: Recommendations for standardization of geographical names in the Republic of Croatia - object group "Transport Infrastructure", Methodology for standardization of geographical names in the Register of Geographical Names and Guidelines for writing geographical names on maps and other publications.

After an expert discussion, the Commission concluded that these documents should be adopted in the first quarter





- 2010: State Geodetic Adminitsration (SGA);
  - Integration of CGN in SGA
- 1999: Croatian Geodetic Institute (CGN)
  - Act on State Survey and Cadastre)
  - Organization and start of GI database development
- 1998: Republic of Croatia became a member of UNGEGN the UN Group of Experts dealing with GN


## Geographical Names Database Development

- 2010 2022 State Geodetic Administration
  - Collected names from TK 25 (120 169)
  - Information system of the Register of Geographical Names
  - Further development of aplication
  - Sharing through network services
- 1999 2010 Croatian Geodetic Institute
  - Collected names from TK 300 (5238)
  - Collected names from TK 200 (10 800)
  - Developed application for collecting and searching GN
