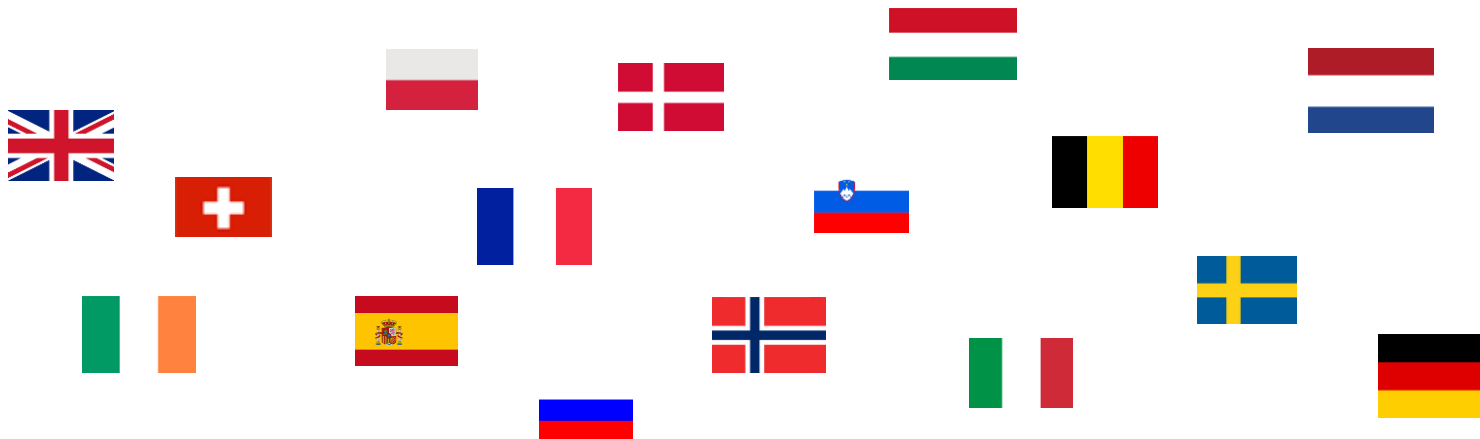

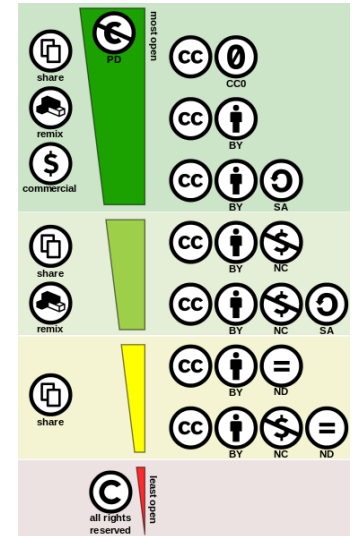
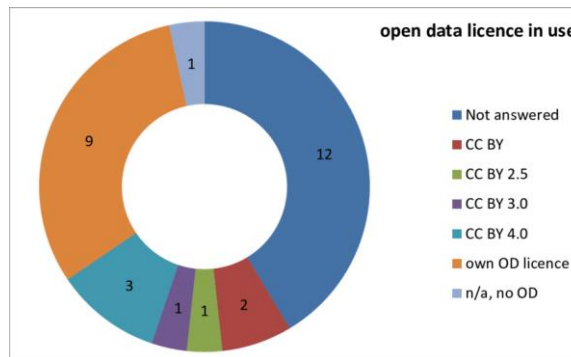

Open ELS Licence

ELSOOpen Licence v1.0

Key Features

This is a readable summary, not a substitute of, the ELS Open Use Licence itself.
