# PROPOSAL TO CREATE A TASK FORCE TO FOSTER INTEGRATION OF MS REFERENCE DATA IN COPERNICUS

## ■ FRAMEWORK OF PROPOSAL

- Proposed by France to Copernicus user Forum and Copernicus Committee

## ■ GOAL OF TASK FORCE: SUPPORT COPERNICUS IN-SITU DATA COORDINATION BY DELIVERING RECOMMENDATIONS AIMING AT

- Fostering **integration** of Member States reference data in Copernicus services
- Supporting Copernicus services in meeting the **requirements** from both European authorities and Member States
- Which requires **consistency** with national data and systems

# PROPOSAL TO CREATE A TASK FORCE TO FOSTER INTEGRATION OF MS REFERENCE DATA IN COPERNICUS (CONT.)


## ■ METHODOLOGY OF THE PROPOSED TASK FORCE

- Analyse the **requirements** from Copernicus services;
- Select appropriate data themes, feature types and attributes from **INSPIRE** data specifications in order to meet Copernicus requirements;
- For this selection define **quality requirements** going farther than current INSPIRE specifications, to enable **data homogeneity** between Member States.

## ■ COPERNICUS WORK PROGRAMME FOR 2016:

- Finnish delegation to Copernicus Committee submitted the following proposal
- *“In 2016, the scope of CORDA will be extended broadening it from geospatial reference data to in situ data in general, and from Land Monitoring and Emergency Management to all Copernicus services. It will enter its operational phase and incorporate European Location Framework components from the ELF project.”*
