

# 2018 work programme

- ▶ Cyber Security package tabled on September 13 including: a proposal to strengthen the Agency for Network and Information Security (ENISA); an implementation toolkit for the Network and Information Security Directive;
- ▶ blueprint for effective response in case of cyber attacks affecting several Member States; enhancing the Union's strategic autonomy by boosting research capacity and building effective cyber defence, cyber hygiene and the right skills both inside Europe and with partners worldwide, including NATO
- ▶ Data package tabled on September 13 unlocking the potential of the data economy by ensuring a free flow of non personal data within Europe
- ▶ Initiative on online platforms to safeguard a fair, predictable, sustainable and trusted business environment in the online economy
- ▶ Proposal on fairness in platform to business relations (Q1 2018)
- ▶ Adoption by the co legislators of 14 legislative proposals including: the telecoms package; Digital Contracts, the copyright package; geo blocking; audio visual and media frameworks; parcel delivery; e-Privacy Regulation; and EU rules on the protection of personal data when processed by EU Institutions and bodies
- ▶ Commission guidance to prepare citizens, business and public administrations for the direct application of the General Data Protection Regulation as of 25 May 2018 to be prepared in close consultation with the Article 29 Working Party/the new European Data Protection Board
- ▶ Revision of the Commission guidelines on market analysis and the assessment of significant market power in the electronic communications sector (Q2 2018) Initiative addressing online platform challenges as regards the spreading of fake information (Q2 2018)
- ▶ REFIT: Public sector information: Review of Directive 2013/37/EU on the re-use of public sector information will create opportunities to open up government data for the benefit of society, reduce regulatory costs and simplify the existing legislation (Q2 2018)

# E-government

## Tallinn Declaration 06 October 2017

- ▶ This marks a new political commitment at EU level on significant priorities towards ensuring high quality, user-centric digital public services for citizens and seamless cross-border public services for businesses.
- ▶ The Member States reaffirmed their commitment to progress in linking up their public eServices and implement the eIDAS regulation and the once-only principle in order to provide efficient and secure digital public services that will make citizens and businesses lives easier.
- ▶ The new European Interoperability Framework (EIF) prepared by the Interoperability Unit of the Directorate-General for Informatics (DG DIGIT), a document providing **47 recommendations for modernising the delivery of public services** nationally and across borders, has been included as **a roadmap to the digitalisation of public administrations** in the Ministerial Declaration on e-Government.
