# Review production year 2018


- New data for ERM: Ukraine, French oversea territories
- Updated ERM themes: BND, TRANS, POP, VEG
- Harmonisation and consolidation of metadata and lineage information for EBM and ERM
- No update of TEN-T by DG MOVE
- Calculated INSPIRE-ID for countries with no ID
- Change of calculation method of ARA and LEN
- Correction of annotation feature class
- Delivery to Eurostat by 20<sup>th</sup> January 2019
- Remaining task:  
Provide EBM 2019 and ERM 2019 to public



# Review production year 2018

- Consistency assessment between EBM and ERM: BuiltupP ↔ Residence of Authority

Before:



- Missing in EBM or ERM
- Different location
- Different RoA / PopulatedPlaceID
- Naming issues
- Different USE
- Duplicate Ids in ERM
- Overlaps ERM

Most countries with under 300 issues

Some countries with more than 1500 issues

Few countries with a really big amount of issues (over 6000)

Summary:

- Response was good and a lot of errors were corrected, but not all Data Producers reacted
- Up to 4 feedback loops were needed to correct errors
- Exceptions were detected
- Consistency will hopefully be improved with changes in ERM template and possibility to check with ERM Validator Tool

- New four year contract with Eurostat for EBM (not for ERM)
- Production of EBM and ERM will go on as usual






# Timetable for Production of EBM and ERM in 2019



# EBM Production in 2019

- New reference date: 31.12.2018
- Changes should be between 01.01.2018 and 31.12.2018 → Effective Date
- EBM 2019 (NUTS 2016) is basis for upcoming provision (see FTP server and/or [Eurostat](#))
- The data model and all documents are kept stable
- NMCA have to update the following content of the EBM database:
  - Feature class EBM\_A → basic EBM geometry
  - Table EBM\_NAM → basic EBM attribution
  - Feature class ResidenceOfAuthority
  - Table EBM\_NUTS → Keep aware of regulation NUTS2016
  - Table EBM\_ISN
- NMCA shall deliver only those feature classes or tables, where changes occur

The production of the next update will be carried out in the usual workflow!

- Changes in data model
  - Removed ICC domain
- Changes in seamless release DB
  - Add placeholders for:

# ERM Production in 2019

- ERM-BND:
  - Derived from EBM
  - Issues to be solved:
    - Coastline for Great Britain
    - Border between Romania and Moldova



# ERM Production in 2019

- Update:
  - Theme Hydrography
    - Change in specification for Spring Point Feature Classes (SpringC, SpringP): Name attributes (NAMN1, NAMN2, NAMA1, NAMA2, NLN1, NLN2) are added (optional)!  
→ Reason: Springs which are in the dataset are considered as landmarks or vital to the environment and often have names
    - New HydroID needed and no NHI available ?  
→ Use ID-Generator in PMS

**ID-Generator.** centrally organized and generated unique ID's



    - Change in specification for USE value of BuiltupP!
    - Harmonisation with EBM

# International Boundaries

- NMCAs are not allowed to make any changes on these boundaries on their own
- In case of issues → contact [ebm@bkg.bund.de](mailto:ebm@bkg.bund.de)
- IB\_Regional\_2020.gdb (on FTP server):
  - InternationalBoundary: Has to be used for EBM/ERM
  - InternationalBoundary\_ERM: Border between Romania and Moldova
  - MaritimeBoundary: 'territorial sea' or 'exclusive economic zone' (used for ERM SeaA)
  - ConnectingFeaturePoint:
    - Store points on the international boundaries, where the edge matching of topographic data has been already agreed for ERM
    - Match your ERM updates to these points (or use them to discuss edge matching with neighbouring countries)
  - FeaturesOnBorder:
    - Point and line features located on the international boundary
    - If there are no changes Data Producers shall not deliver those features again!  
If changes occur please perform edge matching.


