

Background

- December 2010: adoption of the Communication “Towards interoperability for European public services”
- Comm included two annexes:
 1. The European Interoperability Strategy (**EIS**)
 2. The European Interoperability Framework (**EIF**)




The European Interoperability Framework (EIF)

- EIF meant to be a generic framework addressing recommendations to provide seamless digital public services thus guiding the MS in the design and update of their national interoperability framework
- ISA was the main implementing instrument of EIS an EIF
- ISA² will be the principal instrument to implement EIS and EIF for the next 5 years.




REVISION OF EIF

- Is deemed necessary in order to:
 - a) To align to the recent policy developments i.e. DSM, PSI etc.
 - b) With techno trends –cloud computing, big and open data etc.
 - c) To put more focus on the EIF implementation rather than the simple alignment with the national approaches on interoperability




PUBLIC CONSULTATION – ISA action

- Opening date: 6 April 2016
- **Closing date: 29 June 2016**
- General objective: is **to ensure that a coherent vision on interoperability exists in EU**
- Contributions welcomed from: citizens, businesses and private organisations, public administrations, research centres, academic institutions, standardisation organisations, businesses supplying services to public administrations



PUBLIC CONSULTATION – structure

- To select 10 major problems identified as obstructing interoperability
- To refer the main problems faced while implementing the EIF
- To select up to 10 areas in which the EIF is expected to contribute the most
- Etc. etc.
